### IMOS SCHOLARSHIP PROGRAM

#### **Guidelines**

- 1. Periodicity: Annual
- 2. <u>Amount</u>: up to \$3000 (per calculation table IMOS utilizes)
- **3.** <u>Scholarship funds are to be used for</u>: Assistance in pursuing academic, trade school, or vocational education beyond High School.
- 4. <u>Persons Eligible to Apply</u>: Illinois Master Masons in good standing for at least 15 consecutive months, their Spouses and Widows, of the Grand Lodge of Illinois, A.F. & A.M. The 15 month restriction may be lifted if the Illinois Master Mason has been continuously in good standing since being raised, <u>and</u> he was an active member of Illinois DeMolay in good standing for at least one year immediately prior to being raised.

#### 5. Additional Eligibility Criteria:

- a. For an **initial** application, the applicant must satisfy <u>at least one</u> of the following criteria (transcript required):
  - i. Possess a C or higher *cumulative* grade point average from his/her most recently attended school -- or –
  - ii. Possess a B- or higher-grade point average from his/her most recently completed semester/official grading period. -- or –
  - iii. Not having attended school that issues grades during the last 3 years.
- b. For a **renewal** application, the applicant must satisfy <u>at least one</u> of the following criteria (transcript required):
  - i. Possess a B- or higher *cumulative* grade point average from his/her most recently attended school -- or –
  - ii. Possess a B or higher-grade point average from his/her most recently completed semester/official grading period.
- c. Be enrolled, or eligible to enroll, in an accredited College, University, Trade School, or other reasonable and substantive post-high-school program of vocational study <u>which</u> <u>directly relates to obtaining or improving necessary job skills and experiences for the</u> <u>applicant</u>. The applicant must submit proof of enrollment in the form of a letter/certificate from the college, university, trade school, or approved vocational study program.
- d. <u>On the application, the applicant will be asked to provide a brief summary of how the education supported by the scholarship is anticipated to help them secure, maintain, and/or improve their prospects for employment.</u>





#### 6. <u>Renewability</u>:

- a. Awardees may reapply for the scholarship on an annual basis from the date of prior disbursement.
- b. Approval of scholarship renewals are based on eligibility rules in effect at the time of reapplication and are not guaranteed.
- c. There is a lifetime limit of no more than five (5) annual scholarship awards <u>per person</u>. Certain hardship cases may be granted consideration for additional years at the discretion of the IMOS Board of Managers.

#### 7. <u>Awards</u>

- a. Award amounts are subject to scaling based on an applicant's household income and household size.
- b. All awards and amounts are subject to the availability of budgeted funds.
- c. Illinois Grand Lodge in conjunction with the IMOS Board of Managers has final discretion in all matters of scholarship qualification and amounts.
- d. Awards are disbursed directly to the Applicant via direct deposit.

# Deadline

No definitive deadline: completed applications are reviewed on a monthly basis.
